



Building Foundations

One of my least favorite courses in architecture school was called "structures." Specifically, it was about the engineering of structures. I guess since architects design buildings it is logical that they should know something about how building structures are engineered. My structures professor was often frustrated that his students did not fully grasp the importance of engineering in building design. Perhaps it was because architecture majors were much more proficient at geometry than calculus. We preferred designing a building to that of ensuring its structural integrity – that was the mundane work of the engineer.

When I hung out my shingle five years after graduation, I decided that sound structural design was valuable after all. No matter how beautiful my design, shoddy engineering would likely result in failure with adverse financial consequences. As someone said, "Let the architect do his part ever so well, if the foundation be rotten, the building will not stand."

I found myself going back and researching the engineering design principals my structures professor tried to teach me. Structural engineering was more interesting than I remembered, starting with foundation design. Clearly there was an important connection between a building's design and the foundation under it. The superstructure resting upon the foundation was essential in supporting the architectural elements that adorned the building's "bones."

Construction terms are used in the Bible as metaphors for the Church, both in its universal and local aspects. The first mention of the Church in the New Testament is in Matthew 16:18 where our Lord says to his disciples, "I

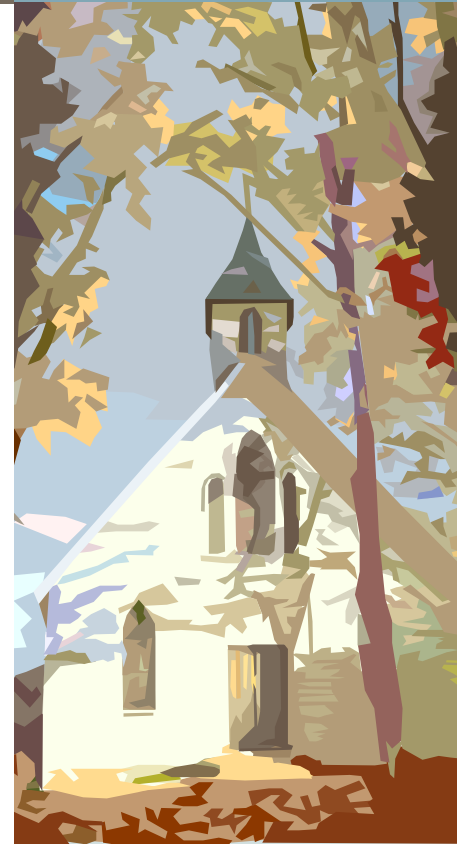
will build my Church upon this rock." Not upon Peter, a singular movable rock, but upon a massive, unmovable Rock – none other than the Lord Jesus Christ himself, the only sure foundation. The Universal Church is that great spiritual edifice which includes all that are in Christ, irrespective of denominational divisions or location. Peter expands upon the metaphor in writing that this spiritual house is built up of "living stones," these stones being built upon the "Chief Cornerstone" *1 Peter 2:5-6*.



Foundations in the ancient world were stone construction. The temple foundation was constructed of massive limestone blocks quarried from the mountains around Jerusalem. The beginning point and most important element in a stone foundation was the cornerstone. Typically, it was the largest stone in the foundation, chosen and quarried with great care as it was the benchmark for the entire structure. The cornerstone was the point of reference to ensure that the entire structure was true and plumb.

Paul states that this immense spiritual building is being "fitly framed together" or "closely joined together" *Eph 2:21*. The phrase is passive, meaning Another is doing the work of masterfully joining together each member of the Church. No wonder – the Lord Jesus is both the Architect and Master Builder; it is His work!

Paul told the Corinthians that he laid the foundation, Jesus Christ, in Corinth for others, like Apollos to build thereon. But he admonished everyone that might undertake the work of spiritual building to take heed how they built upon the Foundation *1 Cor 3:10*. Paul's warning is still relevant in our day. As a homebuilder once said to his client, "If you start right, you can keep right, but if you start wrong it is almost impossible to get right."

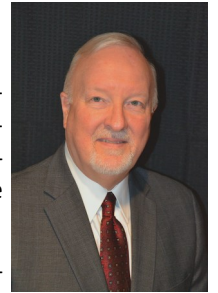

DOING THE WORK OF GOD Is Every True Believer's Responsibility

Haggai 1:3-8, "Then came the word of the LORD by Haggai the prophet, saying, Is it time for you, O ye, to dwell in your paneled houses, and this house *lie* waste? Now therefore thus saith the LORD of hosts; consider your ways. Ye have sown much, and bring in little; ye eat, but ye have not enough; ye drink, but ye are not filled with drink; ye clothe you, but there is none warm; and he that earneth wages earneth wages *to put it* into a bag with holes. Thus saith the LORD of hosts; consider your ways. Go up to the mountain, and bring wood, and build the house; and I will take pleasure in it, and I will be glorified, saith the LORD."

The prophet Haggai had to remind the people that they had misplaced their priorities. The work on the temple had ceased, the people were more concerned about upgrading and improving their own houses that the temple of God.

It is also possible today that we misplace our priorities. The Church is not complete. The disciples had been given a mandate. Matthew 28:19-20, "Go ye therefore, and teach all nations, baptizing them in the name of the Father, and of the Son, and of the Holy Ghost: Teaching them to observe all things whatsoever I have commanded you: and, lo, I am with you always, *even* unto the end of the age."

The work of God is the responsibility of every true believer. Haggai pleads with the people to "consider your ways." The Church is not completed. Let us consider our ways. Let us consider our responsiveness to God in building up and gathering in of those who will believe and be saved.

For many years now we have had the happy privilege of serving those who have a desire to reach out with the gospel. Buildings have been built and upgraded. Properties have been bought that could accommodate the body of believers desiring to set up a testimony for the Lord. Those of you who have stood with us in the ministry have made it

Stewards Foundation has been actively involved in assisting the Lord's servants with the cost of health care for more than 60 years. From 1989 – 2016, \$23,000,000 was given to assist commended workers with the cost of health care expenses. In January, checks totaling \$232,125 were sent to 176 commending assemblies for 302 families, couples and singles in the Health Care Assistance Program (HCAP).



Our commitment to commended workers has lead the Board of Trustees to look for more cost-effective ways to assist with medical expenses. Over the last several years, Assembly Care Ministries (ACM) has been working on a project to help commended workers manage medical expenses. The **Assembly Care Ministries Health Line** is the result of those efforts.

Stewards Foundation has agreed to partner with ACM in advancing this new service that provides medical advice at no cost to commended workers in the U.S. and abroad. **This service is not limited to those in HCAP**, but we want workers in HCAP to be aware of it.
